Official Contest Rules

Entry and Eligibility

This contest runs from 9:00 AM (EST) on November 6, 2018 through to 11:59 PM (EST) on November 30, 2018 ("Contest Period"). You will be entered automatically into the "\$200 Hydro Bill Credit" contest (the "Contest") if you successfully register for eBills on ERTH Power's ("ERTH Power") website at <https://myaccount.ertpower.com/app/register.jsp> during the Contest Period.

This Contest is only open to current residential customers of ERTH Power with an account in good standing, who are receiving their ERTH Power paper bill by mail, who became customers prior to November 6, 2018, and who are 18 years of age or older, excluding the employees, directors, and officers of ERTH Power or any of its affiliates, advertising, and promotional agencies, and agents and representatives and the immediate family members of such employees, directors, and officers, their legal or common-law spouse and/or any persons living in the same household. There is a limit of one (1) entry per successful eBills registration per account.
