

# ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF ERTH POWER CORPORATION

**ERTH Power Corporation has applied to raise its electricity distribution rates effective May 1, 2021.**

ERTH Power Corporation has applied to the Ontario Energy Board to raise its electricity distribution rates effective May 1, 2021. If the application is approved as filed, a typical residential customer of ERTH Power Corporation would see an increase of approximately \$0.16 per month. Other customers, including businesses, may also be affected.

The requested rate increase is set using an Ontario Energy Board approved formula which is tied to inflation and other factors intended to promote efficiency. The Ontario Energy Board intends to review ERTH Power Corporation's request for an inflationary increase in the context of its reported earnings for 2019.

## THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider ERTH Power's application. We will determine whether the company has used the applicable models and formulas required by the OEB and whether to approve ERTH Power's request for a rate change. We will also hear questions and arguments from individuals that have registered to participate (called intervenors) in the OEB's hearing. At the end of this hearing, the OEB will decide what, if any, rate increase will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

## BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review ERTH Power's application on the OEB's website now
- You can file a letter with your comments, which will be considered during the hearing
- You can become an intervenor. As an intervenor, you can ask questions about ERTH Power's application and make arguments on whether the OEB should approve ERTH Power's request. Apply by **January 25, 2021** or the hearing will go ahead without you and you will not receive any further notice of the proceeding
- At the end of the process, you can review the OEB's decision and its reasons on our website

The OEB intends to consider cost awards in this proceeding that are in accordance with the *Practice Direction on Cost Awards* and only in relation to ERTH Power's requested rate change in the context of its 2019 earnings.
